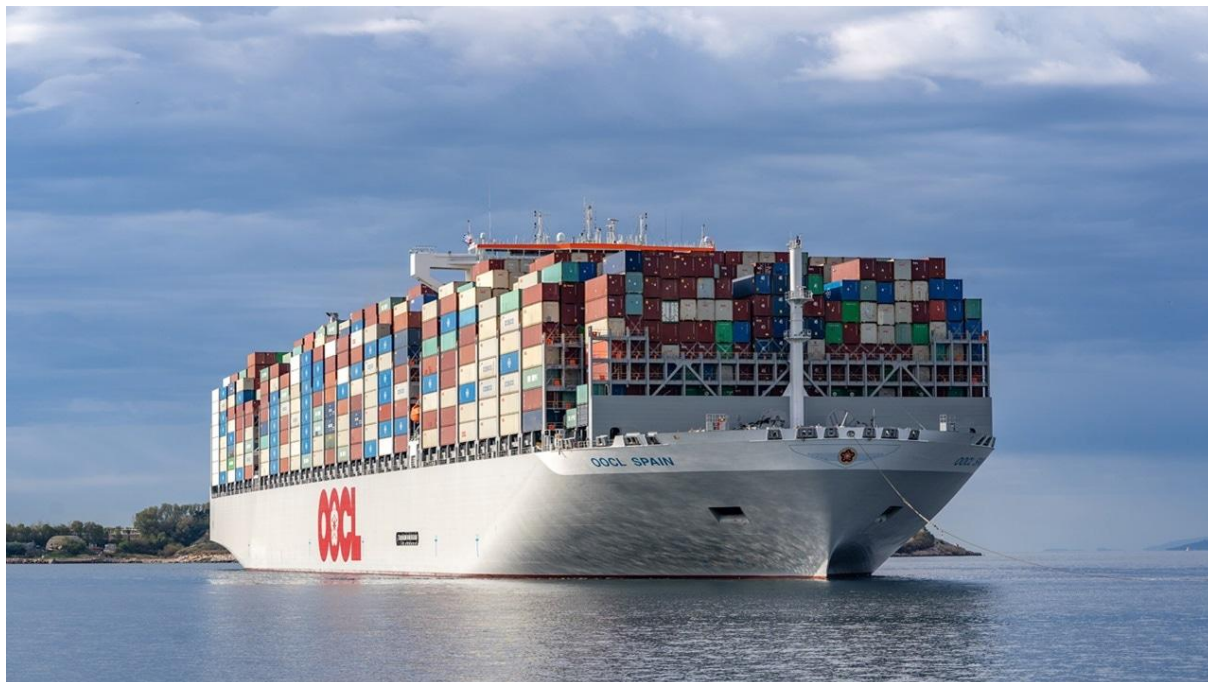


OOCL performs cross-platform eBL transaction

ICE Digital Trade and IQAX launch their interoperable eBL solution, with GSBN which they believe will boost liner adoption.

The first transaction was initiated by OOCL as carrier on IQAX eBL, issuing to a major oil and gas company on ICE CargoDocs, who subsequently transferred to its customer for surrendering back to OOCL.

Adoption of eBL's by shipping lines has been an uphill task. The solution, the first of its kind, breaks down a key barrier towards widespread electronic Bill of Lading (eBL) adoption in containerised flows.

The ability to exchange eBLs across platforms in a secure and legally robust manner marks a significant milestone for the industry and removes a major barrier to adoption of eBLs in the container market.
